

## **VICE x VELUX “ARTIST RESIDENCY” PRIZE DRAW TERMS AND CONDITIONS**

1) The Prize Draw is open to residents of the United Kingdom, Channel Islands and Isle of Man, the Netherlands, United Kingdom, Belgium, Norway, Denmark, and Sweden who are aged 18 years or over, except employees of VICE (“Promoter”) and VELUX (“Partner”) or their affiliated companies, families, cohabitants, agents or anyone professionally connected with the Prize Draw. Proof of age will be required before the prize is dispatched. Entrants will need access to the Internet in order to participate in the Prize Draw.

2) No purchase is necessary for entry into the Prize Draw.

3) The Prize Draw starts on [02-05-2022] at 00:01 GMT and ends on [13-05-2022] at 23:59 GMT. By entering the Prize Draw, you will be deemed to have accepted these terms and conditions. Entries must be received no later than 23:59 GMT on [13-05-2022]. Only one entry per valid email address is permitted.

4) Email entry must be made by the entrant via Instagram, where entrants must: (a) like and comment which piece of artwork is their favorite as posted by VELUX and would like to win (entrants can only win one), (b) Follow @VELUX, and (c) Tag a friend.

Third party entries, bulk entries, or entries submitted by agents, including any entries made by any other individual or any entity, and/or originating at any other Internet website or email address, including but limited to commercial competitions, subscription, notification and/or entering service sites, will be declared invalid and disqualified from this Prize Draw. The use of any device to automate the entry process is prohibited. Entries will not be returned. If entering with a mobile phone or other web-enabled device and using your wireless carrier’s network, standard data charges from your wireless carrier may apply. Check with your wireless service provider for details on these and any other applicable charges. Entrants are solely responsible for any such wireless charges.

5) If there are reasonable grounds to believe that there has been a breach of these terms and conditions by an entrant, the Promoter may, at its sole discretion, invalidate the relevant prize(s) and disqualify the entrant from the Prize Draw. Sale, transfer or exchange of any part of the prize package is strictly prohibited. Any attempt to sell, transfer or exchange any prize(s) will result in the prize(s) being withdrawn by the Promoter and the prize(s) will be declared null and void.

6) No responsibility is accepted for any entries that are incomplete, unreadable, illegible, illegible, corrupted, lost or delayed or are unable to be sent due to technical or any other reason (which shall be disqualified), or for any charge by the senders network for repeat entries. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Promoter.

7) Partner is giving away six (6) prizes in total comprising one (1) print of each artist’s artwork per winner. Therefore in total there will be six (6) winners that each win one (1) different artwork print made by each artist that worked on the VELUX campaign. The prize will be promoted on Instagram.

8) The winner will be the first entry drawn at random from all valid and completed entries on or about [13-05-2022]. A potential winner will be notified by email within 14 days of the relevant draw to the Instagram account provided in the entry. In the event of a dispute as to any Instagram account holder, the authorized account holder of the relevant Instagram account that is chosen as a winner and which was used to enter this Prize Draw will be deemed to be the winning entrant.

The “authorised account holder” is the natural person who is assigned an Instagram account by Instagram when they created an account. The potential winner may be required to show proof of being the authorized account holder. Entrants will only be notified by email if they win a prize. At such time, the potential winner must provide their address and a valid ID in the form of a passport or driving licence and confirm within 48 hours of being notified that they wish to accept the prize. No person may win more than one prize. The prize will be dispatched by **VICE**. The prize will be promptly mailed to the address provided by the winner. Winner will be responsible for all applicable terms and conditions related to the prize.

If a potential winner cannot be contacted or they do not confirm they wish to accept the prize and/or provide relevant information requested by the Promoter within 48 hours of the date of notification, the Promoter reserves the right at its absolute discretion to withdraw prize entitlement and award the prize to a substitute winner subsequently drawn at random from all remaining valid and completed entries. The prize is non-transferable and there is no cash alternative for the prize. The results of the Prize Draw are final and no correspondence will be entered into. Please ensure you are available during this period in case you are a winner.

9) The winner’s entitlement to the prize expires in case of failed delivery, e.g. due to wrong address.

12) By participating, each entrant agrees: (a) to abide by these Terms and Conditions and decisions of Promoter, which shall be final and binding in all respects relating to this Prize Draw; and (b) to the use of his/her name, for editorial, administrative, programming, advertising, publicity and promotional purposes in any and all media, now or hereafter known, worldwide and on the Internet, and in perpetuity by Promoter and its designees, without compensation (unless prohibited by law) or additional consents from entrant or any third party and without prior notice, approval or inspection, and to execute specific consent to such use if asked to do so. 17) To the extent permitted by law, the Promoter and VELUX exclude all liability whatsoever to entrants and the winner in relation to the Prize Draw and the prizes to be awarded. The prize is awarded "as-is" with no warranty or guarantee, either express or implied.
